## TERMS

Upon your signature, \_\_\_\_\_ will reserve the time and date agreed upon, and will not make other reservations for that time and date. For this reason, the Reservation Deposit of \_\_\_\_\_ is non-refundable, even if the date is changed or the wedding cancelled for any reason, including Acts of God, fire, and/or extreme weather.

The Reservation Deposit is applied toward the contracted wedding video package totaling \_\_\_\_\_. The balance of \_\_\_\_\_ is to be paid in full, two weeks prior to the day of the wedding. Videography will not commence before the invoice is paid in full.

Approximately two weeks prior to the wedding, clients must finalize with the videographer a schedule of hours, location(s) and (if desired) an Event Guide (see Addendum A).

It is understood that \_\_\_\_\_ will act as the sole and exclusive wedding videographer.

## HOUSE RULES

Note the videographers are sometimes limited by rules imposed by registrars, ministers and venue management as to what can and cannot be done. For example, venues may restrict the use of lights or limit access to locations. In such circumstances the Clients agree to accept the technical limitations that may be imposed on the equipment used. We advise the Clients to make themselves aware of the rules of the venue concerned and if necessary negotiate with the personnel concerned.

## FOOD/BREAKS

The videographer(s) will be allowed one 20 minute break at their own discretion, and bathroom breaks when necessary. Each videographer will be provided a full guest meal for weddings lasting longer than 5 hours.

## INTELLECTUAL PROPERTY

Client(s) acknowledge that all work created under this agreement is the intellectual property of the videographer who shall retain the copyright to the footage.

Client(s) may post the video online and agree not to digitally manipulate the Work. Any use of the video in featured publications or websites must be accompanied by a credit of "Video By:

## MODEL RELEASE

The Clients grant the videographer and its legal representatives, heirs and assigns, the irrevocable and unlimited consent to use the video of the Clients for editorial, competition, advertising and any other purpose and in any manner and to alter the video without restriction. The Clients hereby release the videographer and its legal representatives, heirs and assigns from all liability and claims in connection with the images.

## LIMITATIONS OF LIABILITY

While the videographer takes the utmost care with respect to shooting, editing and delivering the video, in the event that the video becomes lost, stolen or destroyed, for reasons within or beyond the control of the videographer, liability is limited to a refund of retainer and payment received. The limit of liability shall not exceed the contract price stated herein. \_\_\_\_\_ will not be held responsible for any ruined video footage due to guests and/or other vendors, or outside of \_\_\_\_\_’s control.

In the event that \_\_\_\_\_ is unable to video the wedding due to: illness, emergency, accident, or Act of God, every effort will be made to find a suitable video replacement. If a replacement is unavailable, the payment(s) made to \_\_\_\_\_ will be refunded in full, and return of the payment(s) shall be the entire obligation under this contract. No other damages or guarantees of any kind are recognized or warranted.

# Wedding Video Contract

In the event that the client(s) reschedule the wedding/event and \_\_\_\_\_ is able to rebook the original wedding/event date, \_\_\_\_\_ will amend the wedding/event date in this contract and client(s) will receive credit for all monies paid up to the date client(s) requests the wedding/event be rescheduled.

In the event that the client(s) reschedule the wedding/event and \_\_\_\_\_ is NOT able to book the new wedding/event date, client(s) will forfeit the Reservation Deposit, but receive credit for all other monies paid.

In the event that the client(s) cancels the wedding/event outright, Client will forfeit all monies paid up to the date client(s) notifies \_\_\_\_\_ that the wedding/event is cancelled. Cancellation must be in writing (print or email) even if a phone call was made to inform \_\_\_\_\_ of the cancellation.

## ACKNOWLEDGEMENT OF AGREEMENT

This Contract incorporates the entire understanding of the parties. Any modifications of this Contract must be in writing and signed by both parties.
